This licence has the reference number and regulates the purchase and use of images sold from *Bioquatic Photo* (Bioquatic – A. J. Nilsen, NO-4432 Hidrasund, Norway) to **the buyer** specified with name and address as:

The buyer agrees on the following:

1. Unless otherwise is agreed upon between both parties, publication rights are granted for *one time use only* in the following publication:

The images covered by this licence are specified in the order's image list that follows the licence and referred to on the invoice issued from *Bioquatic Photo*.

Rights are granted for the following printing numbers: copies.

2. *Bioquatic Photo* guarantees that *Bioquatic* – A. J. Nilsen holds the copyrights to all images covered by this licence.
3. All images in this licence are covered by international and Norwegian copyright laws.
4. The copyrights of all images covered by this licence remain with *Bioquatic* – A. J. Nilsen after use.
5. The digital images received from *Bioquatic Photo* can be kept by the customer, but are to be used for the purpose mentioned in #1) only. The material shall not be copied, stored or in any way distributed to other parties or published on other digital media such as on the Internet.
6. Images purchased for digital use shall carry the copyright signature: " *Copyright:* Bioquatic Photo – www.biophoto.net".
7. Use on web sites is *not* covered by this licence but requires a special agreement between the parties.

8. Credits shall be given as follows in photo captions: "Photo: *Bioquatic Photo* – biophoto.net", or alternatively in "List of Photo Contributors" as mentioned in #9). Missing credits shall be compensated with a price corresponding to 50% of the original invoice.
9. If images are used in books, a complete reference to *Bioquatic Photo* is to be printed in the publication where photographers are acknowledged. This acknowledgement is given as:

11. *Bioquatic Photo* is furthermore granted one free copy of the publication mentioned in this licence. The publication is shipped to *Bioquatic Photo* free of cost as soon as possible after printing.
12. The images are shipped digitally free of costs as specified in the order or as agreed upon by both parties.
13. If the buyer is not satisfied with the image's digital quality, he has the right to return the image and cancel to order. Cancellation must be done during a period of 3 weeks after receiving the material.
14. If one or more digital file(s) fail to open, *Bioquatic Photo* will provide you with equal new material without extra costs.
